The Valparaiso Core Program is a two-semester sequence (8 credits total) that introduces first-year students to academic life at the university. This seminar-style program is taught by faculty across the College of Arts and Sciences and the curriculum is multidisciplinary and writing-intensive. This position reports to the Dean of Arts and Sciences. My primary responsibilities:

- Deliver a diverse, rigorous, and engaging yearlong curriculum to 500-700 students that is writing-intensive and introduces students to information literacy.
- Supervise 25-35 faculty members from across the university: Art, Chemistry, Communication, Economics, Education, Engineering, English, History, Music, Philosophy, Political Science, Sociology, Theology, and World Languages.
- Review faculty teaching evaluations.
- Administer Core Lab: Solicit, approve, and promote co-curricular programming that counts for one of the four credits each semester; major new initiatives include the Core Keynote Address, the Core Justice Symposium, the Core Hall of Fame, and a calendar of events that support Core semester themes of empathy, dialogue, justice, and research.
- Manage program budget and procure additional event funding with campus partners.
- Maintain relationships and collaborate with campus partners: University Writing
 Program, Writing Center, Christopher Center Library, Valparaiso Institute for Teaching
 and Learning, Institute for Leadership and Service, Gandhi-King Center for Diversity
 and Global Engagement, Honor Council, Student Life, Sexual Assault Awareness
 Facilitative Education, and many student organizations.
- Create schedule and communicate with the Office of the Registrar.
- Facilitate workshops on Core Program goals, curriculum, and teaching strategies; provide opportunities for faculty development in technology use.
- Develop course themes, curriculum, and co-curricular programming in collaboration with Core faculty and campus partners.

- Coordinate with the Director of the University Writing Program, the Writing Center, and the Information Literacy liaisons to develop student writing and to provide opportunities for faculty development in the teaching of writing.
- Recommend lecturer and adjunct faculty appointments to the Dean of Arts and Sciences.
- Report regularly to the Dean of Arts and Sciences on staffing, scheduling, and associated personnel, budgetary, and logistical issues.
- Coordinate writing initiatives with the Associate Provost and other faculty administrators involved with writing instruction.
- Implement decisions of the General Education committee; report monthly to the General Education Committee on the Core Program; participate in decision-making regarding the General Education Program.
- Provide data and reports to the university accreditation coordinator.
- Assess student learning objectives and curricular design with benchmark data (writing assessments and reading analysis assessments), qualitative data (focus groups and surveys), and assess student retention factors with Starfish Analytics.

The Lilly Project on the Theological Exploration of Vocation was a grant project that funded a range of projects on campus giving students opportunities to explore the concept of vocation. This position reported to the Dean of Arts and Sciences. My primary responsibilities:
