It's almost here, the end of the Fall 2022 semester!! Congrats to those who are graduating, and best wishes in your future!

If you are graduating or finishing a program...

Take a close look at this information about your Final Term, in particular the details about what is allowed during your 60 day (F-1 students) or 30 day (J-1 students) grace period.

In addition, be sure to update your address on **DataVU** & **iValpo** before you graduate, so that the university can know the correct address to mail documents (tax info, diploma, etc) to you after graduation if needed.

If you are continuing at Valpo in Spring 2023...

Don't miss these 5 important reminders!

Reminder #1, International Travel Checklist

- Keep alert to changes in the restrictions on international travel. Although the pandemic-related controls on travel are less than before in many places, there are some places where restrictions continue. So, please be aware of travel & border controls in the region that you are traveling. Also, keep a close eye on the CDC and U.S. State <u>Department</u> travel warning/regulations websites.
- I-20/DS-2019 signature for international travel. if your I-20/DS-2019 has not yet been signed for travel on page 2 (or pg 1 for DS-2019) during the Fall 2022 semester, please submit the <u>Reprint I-20 Request</u> e-form on iValpo, selecting the reason of "travel", and we will process the I-20 signed for travel within 3 business days. NOTE: for DS-2019 signatures, please contact Andrew Knox
- (andrew.knox@valpo.edu) to set up a time for getting the travel signature. Check the expiration dates on your visa, I-20/DS-2019, and passport.
- You can't come back into the US if any of them are expired! Your I-20 must be extended before it expires, and allow for enough time in your home country if you need to renew your visa or passport. Furthermore, some consulates/embassies are closed or have very limited appointments due to the pandemic situation, so if you need to renew your visa, make sure you allow enough time. • Click here for a list of documents to carry when you travel outside the

- Reminder #4 Even while in the U.S., you are required to carry your I-94 record with you at all times.

And remember that if you travel outside the U.S., when you return, your I-94 number will be updated, so make sure you have the most current version and it is correct (F-1 D/S status,


