**\*\*Tuition Remission Students:** This form is REQUIRED from all students who wish to receive aid for classes enrolled for summer. If a Master TR app is on file, you do not need to complete the Part-Time TR app. If a Master TR app is not on file, the Part-Time TR form is REQUIRED in addition to this summer Financial Aid application. Students also interested in taking out loans will need to complete the 2021-2022 FAFSA and be registered at least half-time.

## To Apply for Summer Financial Aid at Valparaiso University

1. To be eligible for federal student loans, you must enroll in at least 6 credit hours as an undergraduate, 4.5 for Graduate, across the entire summer. Classes may be in one session, two sessions or in both. However, you are only eligible for aid for the session(s) for which you are enrolled.
2. Submit the Summer Financial Aid Application to the Financial Aid Office, after you have completed your registration for summer courses.
3. You are also required to complete a 2021-2022 Free Application for Federal Student Aid (FAFSA) and to have the resulting information submitted to the Financial Aid Office. If you had not previously had your data submitted to VU, you may do so by listing VU on your FAFSA (school code 001842).
4. FAFSA must be received and all aid must be processed by the last day of your enrollment period.
5. When your summer application file is complete, a financial aid staff member will complete your summer award and send an award letter to you. If you wish to discuss your summer aid, you are welcome to visit with a financial aid counselor, either when you turn in your application or after you receive your award letter.
6. If we have requested documentation to verify your application (e.g., tax transcripts, W-2 forms, etc.), please be certain those are submitted promptly. Pending financial aid must be cancelled for students whose documentation is not received prior to the last date of enrollment.
7. Please keep in mind that the loans you receive during the summer may affect the loans you receive during the upcoming fall and spring semesters.
