

STUDENT SENATE GENERAL BODY MINUTES DATE: 4/6/2020

1. FORMAL CALL TO ORDER: 8:04pm

3. FORUM OF CONCERNS:

- a. VUDU
 - i. One thing we would like to update is the category "Food for on-campus shows" under Organization Sponsored Events. If we could change the 244 to 300, that would be great.
- b. Alpha Psi Omega
 - i. -Wants line for Theater Banquet fulfilled -If not able to be funded, "Would the Senate be able to transfer funds from one line of this existing budget to another line? I just want to clarify. If that is the case, I would like to make such a request. If we could move \$1000 from American College Theatre Festival under 50430 to the Theatre Banquet, that would be ideal. It isn't strictly a Theater department event; it is more an event that APO and the Theater Department both contribute towards.

c. ACDA

i. The Executive Board of the American Choral Directors Association would like to request that we receive the full \$350 that was requested in our budget proposal for Organization Dues, Subscriptions and Licenses. Currently, the \$70 approved would only cover fees for two memberships (please see the ACDA website here: https://acda.org/membership-central/individual-membership/) If students are not members of the national organization, they will be unable to register to attend the national and local conferences. Despite our other elements of the budget being approved, if only two members are allocated funding to members, no one else could go. Traditionally, we send ten members to a conference every year.

- i. Leadership rally is essential for the leaders in our organization to gain skills to help run the organization. Last year, we received \$400 to send one person. Now that leadership rally will allow for two representatives to go, we would like \$1,000 to send two members of the organization.

 - i. Frustrating concerns related to housing and campus infrastructure. Given the current circumstances, it is understandable how/who the University has allowed students back on campus. However, we would like the student senate to voice our concern and request a refund for half a semester's for: the general fee which funds the infrastructure/facilities (rec, tech, union, etc) on campus, fees for student housing and fees for student dining. One of us was initially barred from returning to campus until waiting out quarantine guidelines but is now not being allowed to

return to campus after waiting them out. Two of us have just been told that we have to leave campus because our jobs do not qualify us to continue staying on campus. We work at a restaurant that has been trying to accommodate the community during this time by providing meals and delivery services and being forced to go back home puts that restaurant and community under more hardship as well as taking away our income from these jobs. One of us lives in a rural community and has had a multitude of accessibility issues which a couple professors have been unwilling to accommodate with completing classwork as he only has access to limited internet at certain times of the day or none at all. His decision for being a resident student was primarily based around the infrastructure and resources the university provides and is otherwise unable to complete coursework without that infrastructure and those resources. Given state issued closures of libraries and restaurants in his hometown, he cannot go out and access alternative internet connections.

We find it drastically unfair and unacceptable to have paid for these services but we are now being barred or have to qualify under an extremely selective checklist in order to access them. We understand and agree with the University's decision to do such actions, but doing so without providing a refund is financially devastating and against the moral character of what our University stands for.

Like many students on campus, we take loans out to assist in paying for our education. Loans with principals which we would not have had to lend as much, or at all, had we only had to pay for half a semester of these resources. Regardless of the government's temporary 0% interest, we still have principal balances which we have to repay despite not receiving the full services its purpose was to pay for.

We paid for a full semester's worth of resources, but we are only being allowed to receive half. Please refund students the prorated amount, with the proration beginning March 15, for these services that are being selective, disrupted, and/or denied from us for which we have paid.
